

NESDA Officer Nominations Form 2018/2019 —
Please take the time to READ This Form Carefully & Thoroughly

As a member of NESDA, you have the opportunity to participate in NESDA's democratic process by nominating the people you know to be qualified and willing to serve as a NESDA officer or director during the next year or two.

Any member may nominate himself or any other member (if qualified according to the rules) for the positions of President, Vice President or director from that region (see NESDA Bylaws and Standing Rules, posted in "Members Only" at NESDA.com, for qualifications). Directors from even-numbered regions are elected in even-numbered years; directors from odd-numbered regions are elected in odd-numbered years (unless to fill a vacated office). In 2010, The Bylaws Committee proposed the addition of a NEW Director At Large. This was approved by a membership vote at the 2010 Membership Meeting. The Director at Large is limited to 4 terms. The President, Vice President, and Director at Large are elected by the membership as a whole and serve one-year terms. The Secretary is nominated and elected by the membership in even-numbered years to serve a two-year term (unless to fill a vacated office). The Treasurer will be nominated and elected from among the elected or appointed directors by the Board of Directors following the annual elections.

Listed at right are the current officers and directors. Those appearing with no asterisk are serving the second year of a two-year term; unless those offices become vacant otherwise, no nominations are needed or accepted from their regions. However, those that appear with an * beside them occupy positions that will be open for elections at the upcoming convention and nominations are being solicited.

Any nominee must be a NESDA member in good standing and must consent to be nominated. Nominations for director from any region must be made only by NESDA members within that region and must be endorsed (in writing) by at least five active members from the region.
